**AMENDMENT TO THE DECLARATION COVENANTS, CONDITIONS,
AND RESTRICTIONS FOR BELLEAU WOOD, A RESIDENTIAL
COMMUNITY TO THE CITY OF EDMOND, OKLAHOMA COUNTY, STATE
OF OKLAHOMA, ACCORDING TO THE RECORDED PLAT THERETO**

THIS AMENDMENT to the protective covenants entitled "DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS" for the Belleau Wood Development is made effective as of the date of filing by Spinning Spur, LLC, an Oklahoma limited liability company, that is the Declarant to Belleau Wood Addition to the city of Edmond, Oklahoma County, State of Oklahoma (the Addition).

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the Addition is a platted addition to Oklahoma County, the Plat being recorded within the Oklahoma County Clerk's Office at Plat Book 65, Page 33 and being particularly described as set out within Exhibit "1" attached to this Amendment.

WHEREAS, certain real property covenants, conditions, and restrictions to the Addition were recorded by Declarant within the Oklahoma County Clerk's Office at Book 10578, Page 1434, as subsequently amended, supplemented, added to, or annexed (collectively, the Covenants).

WHEREAS, the Declarant desires to amend the Covenants to reflect a change in the restriction on firewood storage within the Addition.

NOW THEREFORE, the Covenants to the Addition are hereby amended to add the following language.


Exhibit "F" Initial Design Review Guidelines. 4. Design Standards. General Design Standards. 4.28 Play and Sports Equipment to the Covenants is hereby deleted and replaced with the following:

4.28 Play and Sports Equipment. Play and sports items and equipment must receive DRB approval prior to installation. All play and sports items and equipment must be wholly contained in the backyard to a Lot. Portable basketball backboards and hoops may be used in the front yard of a Lot during daylight hours, but shall be stored out of sight otherwise. Permanent basketball backboards and hoops may be installed in the front yard of a Lot provided placement of the equipment is approved by the DRB prior to installation.

IN WITNESS WHEREOF, the Declarant has approved, adopted, and executed this Amendment.
